

UEFN COLLECTIVE COMMERCIAL USE LICENSE AGREEMENT

This Commercial Use License Agreement ("License") is entered into by and between UEFN Collective ("Licensor") and the purchaser of the Licensed Asset ("Licensee"), and takes effect on the date of Licensee's purchase ("Effective Date"). By downloading, purchasing, accessing, or otherwise using the Licensed Asset, Licensee agrees to be bound by this License.

1. Licensed Asset

"Licensed Asset" means the user interface (UI) asset package purchased by Licensee from Licensor, together with all files delivered as part of that package, in any file type or format whatsoever (including, without limitation, image files such as .png, engine asset files such as .uasset, source files, textures, materials, widgets, and documentation), and including any modified or derivative version of any such file created by or for Licensee.

- The specific package licensed is the one identified in Licensee's purchase receipt or order confirmation for the transaction through which this License was delivered. No separate designation is required for this License to apply.

2. Grant of License

- Subject to Licensee's continued compliance with this License, Licensor grants Licensee a **perpetual, worldwide, non-exclusive, non-transferable, and non-sublicensable** license to use, reproduce, modify, adapt, and incorporate the Licensed Asset within Licensee's own project(s) for commercial purposes, including to generate and retain revenue from such project(s).
- This License is a grant of use only. It is **not** a sale, and no ownership of the Licensed Asset is transferred to Licensee.

3. Permitted Use

- Licensee may incorporate the Licensed Asset into Licensee's own project(s) and may publish, distribute, and monetize those project(s), including on Fortnite, UEFN, and other commercial platforms.
- The Licensed Asset may only be distributed as an integrated, non-extractable component of Licensee's published project(s), and never as a standalone or reusable file.

4. Restrictions

Licensee shall not, and shall not permit or enable any third party to:

- sell, license, sublicense, rent, lend, share, publish, upload, or otherwise distribute the Licensed Asset as a standalone file or in any form or format from which it can be extracted, isolated, or reused;

- redistribute the Licensed Asset through any asset pack, library, marketplace, repository, template, or file-sharing service;
- transfer, assign, or sublicense this License or any rights granted under it to any other person or entity;
- use the Licensed Asset outside the scope of Licensee's own project(s), or for any unlawful purpose;
- claim authorship or ownership of the Licensed Asset, or register or attempt to register any right in it; or
- remove, obscure, or alter any attribution, credit, or proprietary notice provided by Licensors.

5. Ownership

- Licensors is and shall remain the sole and exclusive owner of the Licensed Asset and all intellectual property rights in it. All rights not expressly granted to Licensee under this License are reserved by Licensors.

6. Remedies for Unauthorized Distribution

- Licensee acknowledges that any unauthorized distribution, resale, sharing, or other breach involving the Licensed Asset would cause Licensors immediate and irreparable harm for which monetary damages alone would be inadequate and difficult to calculate.
- As a reasonable pre-estimate of Licensors's damages, and not as a penalty, Licensee shall pay Licensors liquidated damages of **ten thousand U.S. dollars (\$10,000)** for each act of unauthorized distribution of the Licensed Asset.
- In addition to liquidated damages, Licensee shall pay to Licensors all revenue, profits, and other amounts derived directly or indirectly from any such breach.
- Licensee agrees that Licensors shall be entitled to immediate injunctive and equitable relief to prevent or stop any breach, without the requirement of posting a bond, in addition to all other remedies available at law or in equity.
- Licensee shall reimburse Licensors for all reasonable attorneys' fees, court costs, and enforcement expenses incurred in connection with any breach.
- Any breach of this License automatically and immediately terminates the license granted herein, and Licensee shall immediately cease all use of, and permanently delete every copy of, the Licensed Asset in its possession or control.

7. Term and Termination

- This License is perpetual and remains in effect unless and until terminated in accordance with its terms.
- This License terminates automatically upon any breach by Licensee, and may otherwise be terminated by Licensors upon written notice if Licensee fails to comply with

any term and does not cure within ten (10) days.

- Upon termination, all rights granted to Licensee end immediately, and Licensee shall cease all use of and delete all copies of the Licensed Asset. Sections 4, 5, 6, 8, and 9 survive termination.

8. Governing Law

- This License is governed by and construed under the laws of the State of Washington, United States, without regard to its conflict-of-law principles. The exclusive jurisdiction and venue for any dispute arising out of this License shall be the state and federal courts located in Washington State, United States, and the prevailing party shall be entitled to recover its reasonable attorneys' fees and costs.

9. Acceptance and Entire Agreement

- No signature is required. This License takes effect and binds Licensee upon the earliest of Licensee's download, purchase, receipt, access, or use of the Licensed Asset, each of which constitutes Licensee's acceptance of these terms.
- This License is the entire agreement between the parties regarding the Licensed Asset and supersedes all prior communications, representations, or agreements, whether oral or written. It may be modified only by a writing signed by Licensor.

Order Details

- Licensee: the individual or entity identified in the purchase receipt for the order.
- Licensed Asset: the UI asset package named in the purchase receipt for the order.
- License Fee: the amount paid by Licensee, as shown in the purchase receipt.
- Effective Date: the date of Licensee's purchase, as shown in the purchase receipt.
